## 2. FOR INFORMATION

Children and young people who take part in activities with Investing in Children are paid a fee for participating plus travelling expenses (paid at public transport rates). This is paid in cash directly to the young person. The fees payable can include:

<i>Agenda Days</i>	<i>£5 (where activities are not included)</i>
<i>Facilitating</i>	<i>up to £20</i>
<i>Training</i>	<i>up to £50 per day</i>
<i>Attending meetings</i>	<i>£5 - £10</i>

### **3. GENERAL CONSENT** (please read carefully)

- a) Investing in Children is an organisation concerned with the human rights of children and young people aged 0-24. We hold various **meetings and research groups** for children and young people to make changes where they live. These activities are always under the supervision of a suitably qualified member of staff.
- b) Investing in Children believes that children and young people should be **rewarded** if they give up their time to contribute to the various projects we run. For attending Agenda Days, this is normally a fee of £5 unless additional activities are included. For other work, we sometimes pay an hourly rate, or negotiate different forms of reward with particular groups. We also cover travel expenses. We enclose information on the various travel schemes that offer reduced fares. We expect where possible that you will make use of these schemes, and where a reduced fare is available, we will pay your travel expenses at this rate. I also consent for the child/young person to be occasionally transported by Investing in Children workers if the need arises.
- c) I give consent for my/my child's **photograph** and / or **video** to be taken and used by Investing in Children for public documents and publications, websites, and other social media channels (including You Tube linked to the Investing in Children website and Facebook pages). I also consent for my/my child's photograph and/or video to be taken and used by the local and national press and media, and understand that any photographs and videos may be redistributed by third parties outside of the control of Investing in Children.
- d) I agree to my son / daughter receiving **medication** (if instructed) and any emergency dental, medical or surgical treatment, including anaesthetic or blood transfusion, as considered necessary by the medical authorities present. I will inform Investing in Children as soon as possible of any changes in the medical or other circumstances between now and end of above group / activities.
- e) I understand that Investing in Children and its staff are covered by Investing in Children's **insurance policy** and understand that details of this policy is available upon request.
